Privacy Policy

Our committment and respect for your privacy

Your privacy is important to us. To better protect your privacy, we provide this notice explaining our online information practices and the choices you can make about the way your information is collected, used and protected. Our privacy policy is designed in such a way that through the experience and interaction you have with our website, there is minimal information garnedered; essentially building trust so that we can embark on a future working relationship together.

The types of information we collect

We collect information from you when you login to our site to review design comps, place an order through our digital storefront, or fill out a form such as the response form in the contact section. When using the storefront to order a product or design, logging in to review designs in our password protected area, as appropriate, you may be asked to enter your: name, e-mail address or phone number. You may, however, visit our site anonymously.

How we use the information you provide

The information we collect from you may be used in one of the following ways: To personalize your experience, to improve our website, to improve customer service, to process transactions and/or to administer a contest, promotion, survey or other site feature.

Furthermore, we use the information you provide about yourself when placing an order only to complete that order. We do not share this information with outside parties except to the extent necessary to complete that order.

How we protect your information

There are several instances that require the collection of a user's personal information. When applicable, such as purchasing products/services via our digital storefront, we make use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology, encrypted then passed on to a secure Payment gateway. Once the information arrives at one of our selected payment gateways (PayPal and/or Google Checkout) it is then only accessible by those authorized with special access rights and are required to keep the information confidential. **After a transaction, your private information will not be stored on our servers.**

The use of cookies (or lack thereof)

Cookies are small files that a site or its service provider transfers (if you allow) to your computer's hard drive through your Web browser enabling the sites or service providers' systems to recognize your browser and remember certain information. **We do not currently make use of cookies**, although at some point in the future that may change with the implementation of advertising and managing affiliate partnerships. If and when cookies are to be implemented, we will post a notice that the Privacy Policy has changed.

Disclosure of information to outside parties

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential.

We therefore have no responsibility or liability for the content and activities of these linked sites. Nonetheless, we seek to protect the integrity of our site and welcome any feedback about these sites.
